**CONTRACT AGREEMENT**

THIS AGREEMENT, made this **JUL 04 2025** between:

The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the **Department of Public Works and Highways Quezon 4<sup>th</sup> District Engineering Office (DPWH QUEZON 4<sup>TH</sup> DEO)** represented herein by **RODEL O. FLORIDO**, District Engineer, duly authorized for this purpose, with main office address at Brgy. Panikihan, Gumaca, Quezon hereinafter called the "Procuring Entity";

-and-

**BOMEL CONSTRUCTION** a single proprietorship/ partnership/ corporation/ Joint Venture organized and existing under and by virtue of Laws of the Republic of the Philippines, with main office address at 1226 Landing Rd., Ibabang Iyam, Lucena City, Quezon Province, IV-A, represented herein by **ROBERTO T. DE VERO**, Owner duly authorized for this purpose, hereinafter called the "Contractor".

WHEREAS, the Entity is desirous that the Contractor execute **25DL0192 - 71X - SPECIAL MAINTENANCE, REPAIR AND REHABILITATION OF DAMAGED PAVED ROADS - PRIMARY ROADS ALONG MAHARLIKA HIGHWAY (LZ), K0195+875 - K0195+902 LS, K0195+933 - K0195+942 LS, GUMACA, QUEZON** (hereinafter called "the Works") and the Entity has accepted the Bid for **One Million Seventy Two Thousand Five Hundred Pesos (PHP 1,072,500.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

In consideration for the sum of ***One Million Seventy Two Thousand Five Hundred Pesos (PHP 1,072,500.00)*** or such other sums as may be ascertained, BOMEL CONSTRUCTION agrees to ***25DL0192 - 71X - SPECIAL MAINTENANCE, REPAIR AND REHABILITATION OF DAMAGED PAVED ROADS - PRIMARY ROADS ALONG MAHARLIKA HIGHWAY (LZ), K0195+875 - K0195+902 LS, K0195+933 - K0195+942 LS, GUMACA, QUEZON*** in accordance with his/her/its Bid.
4. The ***Department of Public Works and Highways Quezon 4<sup>th</sup> District Engineering Office (DPWH QUEZON 4<sup>TH</sup> DEO)*** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
