



 - Instructions to Bidders (ITB) and Bid Data Sheet (BDS)
 - Supplemental/Bid Bulletins for Bidding Documents
 - Special Conditions of Contract (SCC)
 - General Conditions of Contract (GCC)
 - Specifications
 - Drawings
 - Performance Security
 - Other Documents
 - Construction Methods
 - Construction Schedule in the form of PERT/CPM Diagram or Precedence Diagram and Bar Chart with S-Curve, or other approved tools of project scheduling, and Cash Flow.
 - Manpower Schedule
 - Equipment Utilization Schedule
 - Construction Safety and Health Program initially approved by the Head of the Procuring Entity
 - CONTRACTOR's** All Risk Insurance (CARI)
- In consideration of the payments to be made by the **PROCURING ENTITY** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **PROCURING ENTITY** to execute and complete the **Works** and remedy any defects therein in conformity with the provisions of this **CONTRACT AGREEMENT** in all respects.
- In consideration of the execution and completion of the **Works** by the **CONTRACTOR**, the **PROCURING ENTITY** hereby covenants to pay the **CONTRACTOR** the unit prices in the **CONTRACTOR's** Calculated Bid, as applied to the actual quantities accomplished as certified by the **PROCURING ENTITY** under the provisions of this **CONTRACT AGREEMENT**, at the times and in manner prescribed by this **CONTRACT AGREEMENT**.


