CONTRACT AGREEMENT

MITMUG, MPA, ASEAN Eng.**, duly authorized for this purpose, with main office address at Brgy. Lanao, Kidapawan City, hereinafter called the "**Entity**" and **PADER CONSTRUCTION & SUPPLY**, with main office address at Brgy. Poblacion, Libungan, Cotabato represented by **ELIZABETH G. LAZARO** duly authorized for this purpose, hereinafter called the "**Contractor**".

WHEREAS, the **Entity** is desirous that the Contractor execute **25MI0066 - CONSTRUCTION OF MULTI-PURPOSE BUILDING (COVERED COURT) FOR KIBUDTUNGAN NATIONAL HIGH SCHOOL IN BRGY. KIBUDTUNGAN, CARMEN, COTABATO** hereinafter called "**the Works**" and the Entity has accepted the Bid for **FOUR MILLION NINE HUNDRED FORTY ONE THOUSAND FOUR HUNDRED TWENTY FOUR PESOS & 99/100 (P4,941,424.99) ONLY** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **Agreement**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:

    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration of the payments to be made by the **PROCURING ENTITY** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **PROCURING ENTITY** to execute and complete the Works and remedy any defects therein in conformity with the provisions of this **CONTRACT AGREEMENT** in all respects. ***Furthermore, a slippage of more than 30 days from the original schedule would result in nonpayment, cancellation of the contract, blacklisting of the erring contractor, and the entry of new contractor who will finish the project.***
4. In consideration for the sum of **FOUR MILLION NINE HUNDRED FORTY ONE THOUSAND FOUR HUNDRED TWENTY FOUR PESOS & 99/100 (P4,941,424.99) ONLY** or such other sums as may be ascertained, **PADER CONSTRUCTION & SUPPLY** agrees to execute and complete the **WORKS** in accordance with his/her/its Bid.
5. The **Department of Public Works and Highways (DPWH) Cotabato 3<sup>rd</sup> District Engineering Office** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
