CONTRACT AGREEMENT

THIS AGREEMENT made this 11th day of July, 2025 between **Department of Public Works and Highways**, with offices address at Tambubong, San Rafael, Bulacan, represented by **EDGARDO C. PINGOL, District Engineer** (hereinafter called the "Entity") and **JAIME Y. VICEO JR. CONSTRUCTION** with office address at DRT Highway Sabang Baliwag 3006 Baliuag Bulacan, represented by **JAIME YAMBAO VICEO JR. - Authorized Managing Officer** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **25CP0111: CONVERGENCE AND SPECIAL SUPPORT PROGRAM - Basic Infrastructure Program (BIP) - BIP - Access Roads and/or Bridges from the National Roads leading to Major/Strategic Public Buildings/ Facilities - Construction of Road, Barangay Biak-na-Bato, San Miguel, Bulacan** (hereinafter called "the Works") and the Entity has accepted the Bid for **Four Million Eight Hundred Seventy Three Thousand Seven Hundred Ninety Nine Pesos and 84/100 Only (Php 4,873,799.84)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESS AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act. No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental and Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals (Bid Evaluation – as calculated, if applicable) and all other documents or statements submitted;

Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's respond to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBSs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Four Million Eight Hundred Seventy Three Thousand Seven Hundred Ninety Nine Pesos and 84/100 Only (Php 4,873,799.84)** or such other sums as may be ascertained, **JAIME Y. VICEO JR. CONSTRUCTION**, agrees to implement and complete the construction of the *25CP0111 - CONVERGENCE AND SPECIAL SUPPORT PROGRAM - Basic Infrastructure Program (BIP) - BIP - Access Roads and/or Bridges from the National Roads leading to Major/Strategic Public Buildings/ Facilities - Construction of Road, Barangay Biak-na-Bato, San Miguel, Bulacan*, within **Sixty (60) calendar days** in accordance with his/her/its Bid.
4. The **DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS** agrees to pay the above-mentioned sum in accordance with the terms of Bidding.


