CONTRACT AGREEMENT

THIS AGREEMENT made this 11th day of July, 2025 between **Department of Public Works and Highways**, with offices address at Tambubong, San Rafael, Bulacan, represented by **EDGARDO C. PINGOL**, District Engineer (hereinafter called the "Entity") and **EIRISH BUILDERS & SUPPLY INC.** with office address at 242 Gulod Maguinao, San Rafael, Bulacan, represented by **EDISON M. VENERACION** – President (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **25CP0177: CSSP - Basic Infrastructure Program (BIP) - BIP - Multi-Purpose Buildings/ Facilities to Support Social Services - Construction of Multi-Purpose Building in Maronquillo High School San Rafael Bulacan** (hereinafter called "the Works") and the Entity has accepted the Bid for **Sixty Three Million Three Hundred Eighty Two Thousand Nine Hundred Seventy Two Pesos and 29/100 Only (Php 63,382,972.29)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESS AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act. No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental and Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals (Bid Evaluation – as calculated, if applicable) and all other documents or statements submitted;

Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's respond to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBSs. **Winning bidder agrees that additional contract documents or information prescribed**

In consideration for the sum of **Sixty Three Million Three Hundred Eighty Two Thousand Nine Hundred Seventy Two Pesos and 29/100 Only (Php 63,382,972.29)** or such other sums as may be ascertained, **EIRISH BUILDERS & SUPPLY INC.**, agrees to implement and complete the construction of the *25CP0177 - CSSP - Basic Infrastructure Program (BIP) - BIP - Multi-Purpose Buildings/ Facilities to Support Social Services - Construction of Multi-Purpose Building in Maronquillo High School San Rafael Bulacan*, within **Three Hundred (300) calendar days** in accordance with his/her/its Bid.
4. The **DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS** agrees to pay the above-mentioned sum in accordance with the terms of Bidding.


