- h. Manpower Schedule (Use Form DPWH-INFR-47).
- i. Equipment Utilization Schedule (Use Form DPWH-INFR-48).
- j. Construction Safety and Health Program (Use Form DPWH-INFR-49).
- k. Contractor's All Risk Insurance (CARI)
- l. Latest Income Tax and Business Returns duly stamped and received by BIR and duly validated with the tax payments made. Tax Clearance from the BIR to prove full and timely payment of taxes
- m. For a local contractor, Certification under oath stating that the Contractor is free and clean of all tax liabilities


