

WHEREAS, the earlier mentioned project was short of award pending availability of fund.

- g. Manpower Schedule (Use Form DPWH-INFR-47).
- h. Equipment Utilization Schedule (Use Form DPWH-INFR-48).
- i. Construction Safety and Health Program (Use Form DPWH-INFR-49).
- j. Contractor's All Risk Insurance (CARI).
