- g. Manpower Schedule (Use Form DPWH-INFR-47).
- h. Equipment Utilization Schedule (Use Form DPWH-INFR-48).
- i. Construction Safety and Health Program (Use Form DPWH-INFR-49).
- j. Contractor's All Risk Insurance (CARI).
- k. Latest Income Tax and Business Returns duly stamped and received by BIR and duly validated with the tax payment made. Tax Clearance from the BIR to prove full and timely payment of taxes.
