**WHEREAS**, in response to the said Invitation to Bid, the BAC received three (3) bids before the deadline of submission of bids for the said Contract on March 19, 2020 at 10:00 A.M.;

**WHEREAS**, the Approved Budget for the Contract (ABC) is in the amount of **PhP 4,950,000.00**;

**WHEREAS**, before opening the bids, the BAC-Technical Working Group (TWG) conducted the electronic eligibility check of the bidders through the DPWH Civil Works Application (CWA), the result generated of which deemed **all bidders eligible** to participate the bidding for the said Contract;

**WHEREAS**, using the non-discretionary "pass-fail" criteria, all bidders passed during the preliminary examination of technical and financial components of the bidding documents;

**WHEREAS**, the amounts of bids of eligible bidders as read are as follows:


