WHEREAS, the DPWH-Cagayan 3rd District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on May 08, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

WHEREAS, in response to the said Invitation, two (2) interested bidders purchased bidding documents from May 08, 2025 until the deadline for the submission of bids, to wit:

1. MAIDA'S CONSTRUCTION
2. KNI88 HARDWARE AND CONSTRUCTION SUPPLY

WHEREAS, the prospective bidders MAIDA'S CONSTRUCTION and KNI88 HARDWARE AND CONSTRUCTION SUPPLY, submitted their respective bids on May 27, 2025 on the prescribed place and time;

WHEREAS, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;

KNI88 HARDWARE AND CONSTRUCTION SUPPLY	P2,900,922.00	-2.33%	The total calculated bid price increased due to rounding off into two decimal places.

WHEREAS, after the bid evaluation conducted by the TWG and as presented to the BAC, the result showed that MAIDA'S CONSTRUCTION and KNI88 HARDWARE AND CONSTRUCTION SUPPLY, were found compliant to the requirements of the financial envelope, hence, recommended as complying;

WHEREAS, the TWG completed the post-qualification to the Lowest Calculated Responsive Bidder, **MAIDA'S CONSTRUCTION** on June 13, 2025. Result showed that the bidder has satisfied the legal, technical and financial requirements of the Bidding Documents, hence, the BAC found its bid responsive and, therefore, the bidder is **post-qualified**;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare **MAIDA'S CONSTRUCTION**, the Bidder with the Lowest Calculated Responsive Bid (LCRB) for the above Contract; and
- To recommend to the **District Engineer** for approval the award of the said Contract to **MAIDA'S CONSTRUCTION** the Lowest Calculated Responsive Bid (LCRB) at its total submitted bid or total Calculated Bid, whichever is lower, in the amount of **TWO MILLION EIGHT HUNDRED SEVENTY SEVEN THOUSAND NINE HUNDRED EIGHTEEN PESOS AND 32/100 (P2,877,918.32).**
