WHEREAS, the DPWH-Cagayan 3rd District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on March 18, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

WHEREAS, in response to the said Invitation, two (2) interested bidders purchased bidding documents from March 18, 2025 until the deadline for the submission of bids, to wit:

- 1. NORTH WIDE JAAR CONSTRUCTION CORPORATION
- 2. JVC CONSTRUCTION

WHEREAS, the prospective bidders NORTH WIDE JAAR CONSTRUCTION CORPORATION and JVC CONSTRUCTION, submitted their respective bids on April 07, 2025 on the prescribed place and time;

WHEREAS, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;

Result showed that the bidder has satisfied the legal, technical and financial requirements of the Bidding Documents, hence, the BAC found its bid responsive and, therefore, the bidder is **post-qualified**;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare **NORTH WIDE JAAR CONSTRUCTION**, the Bidder with the Lowest Calculated Responsive Bid (LCRB) for the above Contract; and
- b) To recommend to the District Engineer for approval the award of the said Contract to NORTH WIDE JAAR CONSTRUCTION the Lowest Calculated Responsive Bid (LCRB) at its total submitted bid or total Calculated Bid, whichever is lower, in the amount of <u>TWO MILLION EIGHT HUNDRED SEVENTY SEVEN THOUSAND</u> <u>EIGHT HUNDRED FIFTY SIX PESOS AND 94/100 (P2,877,856.94).</u>
