WHEREAS, the DPWH-Cagayan 3rd District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on February 28, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

WHEREAS, in response to the said Invitation, two (2) interested bidders purchased bidding documents from February 28, 2025 until the deadline for the submission of bids, to wit:

- 1. 5MJ'S CONSTRUCTION
- 2. 4MD JSL CONSTRUCTION INC.

WHEREAS, the prospective bidders 5MJ'S CONSTRUCTION and 4MD JSL CONSTRUCTION INC., submitted their respective bids on March 20, 2025 on the prescribed place and time;

WHEREAS, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;

WHEREAS, the BAC thru the TWG found out that 5MJ'S CONSTRUCTION have attached its updated Mayor's Permit, BIR Tax Clearance, PhilGEPS Registration and PCAB License Certificates, as well as 4MD JSL CONSTRUCTION INC., which attached its latest NFCC, with Audited Financial Statements stamped "Received" by the Bureau of Internal Revenue (BIR), on their submitted technical envelopes, thus, the BAC rated both bidders "passed" in the preliminary examination, and proceeded with the opening of their financial bids, however, the said bidders were subjected for Unlocking in the Civil Works Application (CWA). WHEREAS, the BAC forwarded updated certified true copies of 5MJ'S CONSTRUCTION's, Mayor's Permit, BIR Tax Clearance, PhilGEPS Registration and PCAB License Certificates, along with updated NFCC of 4MD JSL CONSTRUCTION INC., stamped "Received" by the Bureau of Internal Revenue (BIR) on its Audited Financial Statements, including PhilGEPS Registration Certificate to the Procurement Service, DPWH-Central Office for updating, and a Request for Unlocking at CWA, in order for the BAC to re-process the eligibilities of the said bidders;

WHEREAS, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the above-mentioned bids on March 21, 2025 which resulted in the following bid as calculated:

Result of detailed bid evaluation:

4MD JSL CONSTRUCTION INC.	P4,924,757.27	-0.51%	The total calculated bid price increased due to rounding off into two decimal places.

WHEREAS, after the bid evaluation conducted by the TWG and as presented to the BAC, the result showed that 5MJ'S CONSTRUCTION and 4MD JSL CONSTRUCTION INC., were found compliant to the requirements of the financial envelope, hence, recommended as complying;

WHEREAS, on March 27, 2025, the BAC received the approval of the request for unlocking thru email (outlook). The BAC thru the BAC-Secretariat conducted the re-processing of the eligibility check for 5MJ'S CONSTRUCTION and 4MD JSL CONSTRUCTION INC., wherein both bidders were found eligible;

WHEREAS, the TWG completed the post-qualification to the Lowest Calculated Responsive Bidder, **5MJ'S CONSTRUCTION,** on March 28, 2025. Result showed that the bidder has satisfied the legal, technical and financial requirements of the Bidding Documents, hence, the BAC found its bid responsive and, therefore, the bidder is post-qualified;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare 5MJ'S CONSTRUCTION, the Bidder with the Lowest Calculated a) Responsive Bid (LCRB) for the above Contract; and
- b) To recommend to the **District Engineer** for approval the award of the said Contract to 5MJ'S CONSTRUCTION the Lowest Calculated Responsive Bid (LCRB) at its total submitted bid or total Calculated Bid, whichever is lower, in the amount of FOUR MILLION EIGHT HUNDRED NINETY NINE THOUSAND FIVE HUNDRED SEVENTY TWO PESOS AND 06/100 (P4,899,572.06).
