WHEREAS, the **Department of Public Works and Highways, Iloilo 2nd District Engineering Office, Balabag, Dumangas, Iloilo** advertised the Invitation to Bid for the above-stated Contract and posted the same at the websites of the DPWH, PhilGEPS, and in a conspicuous place at the premises of the **DPWH - Iloilo 2nd District Engineering Office, Balabag, Dumangas, Iloilo** continuously for seven (7) days starting on October 23, 2024;

WHEREAS, in response to the said Invitation to Bid, the BAC received four (4) bids before the deadline of submission of bids for the said Contract on November 12, 2024, at 10:00 A.M.;

WHEREAS, the Approved Budget for the Contract (ABC) is in the amount of **PhP 1,980,000.00;**

WHEREAS, before opening the bid, the BAC-Technical Working Group (TWG) conducted the electronic eligibility check of the bidders through the DPWH Civil Works Application (CWA), the results generated of which deemed **all bidders eligible** to participate the bidding for the said Contract;

WHEREAS, using the non-discretionary "pass-fail" criteria, all bidders passed during the preliminary examination of technical and financial components of the bidding documents;


