
NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a. To declare **JGO BUILDERS** as the Bidder with the Lowest Calculated Responsive Bid (LCRB) for the abovementioned Contract; and


