WHEREAS, the Southern Leyte 1st Engineering District conducted a competitive/public bidding of the above stated contract and posted the Invitation to Bid at the websites of the DPWH on May 28, 2025 and the PhilGEPS and at a conspicuous place at the premises of the Southern Leyte 1st District Engineering Office continuously for seven (7) days starting on May 28 - June 3, 2025;

WHEREAS, in response to the said Invitation, the BAC received Three (3) bids for the Contract as of the deadline for the submission of Bids on June 17, 2025;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:




