### BAC RESOLUTION DECLARING FAILURE OF BIDDING

#### **BAC RESOLUTION NO. 089** Series of 2025

**WHEREAS**, the Department of Public Works and Highways (DPWH) Davao de Oro 1st District Engineering Office, Nabunturan, Davao de Oro, through the Bids and Awards Committee (BAC), posted the Invitation to Bid No. 2025-012 for the above-stated contract on the DPWH and PhilGEPS websites, as well as in conspicuous places within the office premises, for seven (7) consecutive days from May 20-26, 2025;

**WHEREAS**, the Approved Budget for the Contract (ABC) is Php1,999,910.51;

**WHEREAS**, in response to the said Invitation, the BAC received a lone bid from **ROSBILL CONSTRUCTION AND SUPPLY** for the Contract before the deadline for the submission of bids on June 10, 2025;

**WHEREAS**, on June 10, 2025, the BAC, conducted eligibility checking through the Contractor's Profile Eligibility Processing (CPEP) using the Civil Works Application (CWA), which results showed that **ROSBILL CONSTRUCTION AND SUPPLY** passed the Net Financial Contracting Capacity (NFCC) but failed to meet the Work Experience requirement due to a mismatch with the Contract Profile;

**WHEREAS**, on the same day, the BAC with the assistance of BAC-TWG, conducted a manual examination of the Technical Components of the Bids, to verify whether the Work Experience as their Single Largest Completed Contract (SLCC) document was attached. Unfortunately, while the updated document was submitted, it still does not meet the Work Experience with the required category of the Contract. Consequently, the Financial Component was not opened, as the bidder did not pass the Technical Component evaluation;

**WHEREAS**, pursuant to Section 35.1.b of Republic Act (RA) No. 9184 and its Implementing Rules and Regulations (IRR), *"The BAC shall declare the bidding a failure when all prospective bidders are declared ineligible;"*

**NOW, THEREFORE**, for and in consideration of the above premises, the BAC for Civil Works hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare a failure of bidding for the above-mentioned contract pursuant to Section 35.1.b of the RA 9184;
- b.) To cancel the above-mentioned contract in the DPWH and PHILGEPS websites;
- c.) To recommend for re-advertisement of the above-mentioned contract; and
- d.) To recommend to the District Engineer the approval of herein resolution.




