**RESOLUTION RECOMMENDING THE DECLARATION OF FAILURE OF** BIDDING AND THE SUBSEQUENT CANCELLATION OF PROCUREMENT ACTIVITIES POSTED/PUBLISHED IN THE PHILIPPINE GOVERNMENT **ELECTRONIC PROCUREMENT SYSTEM (PhilGEPS) AND DPWH WEBSITES** UNDER CONTRACT ID NO. 25N00011, THE PROJECT FOR ENTITLED: "BUTUAN CITY - MALAYBALAY RD (S00431MN) - K1241+336 - K1241+401, (S00433MN) - K1241+405 - K241+507, K1262+263 -K1263+384, K1263+455 - K1264+405, K1264+476 - K1265+480, K1266+000 - K1268+100, K1269+000 - K1270+000, BUTUAN CITY" WITH AN APPROVED BUDGET FOR THE CONTRACT (ABC) OF PHP 193,000,000.00

**WHEREAS**, the Department of Public Works and Highways (DPWH) Regional Office XIII, through its Bids and Awards Committee (BAC) and BAC Secretariat, published the Invitation to Bid (IB) for Contract ID No. 25N00011 from February 13 to 19, 2025, through the PhilGEPS and DPWH websites and in a conspicuous place within Regional Office XIII for seven (7) calendar days;

*WHEREAS*, the following prospective bidders purchased the bidding documents, submitted their bids on time, and were found eligible during the evaluation of the Civil Works Application (CWA) eligibility processing:

*WHEREAS*, the project, as described in the Fiscal Year 2025 General Appropriations Act (GAA), is entitled: "Butuan City – Malaybalay Rd (S00431MN) – K1241+336 – K1241+401, (S00433MN) – K1241+405 – K241+507, K1262+263 – K1263+384, K1263+455 – K1264+405, K1264+476 – K1265+480, K1266+000 – K1268+100, K1269+000 – K1270+000, Butuan City,";

*WHEREAS*, the Planning and Design Division, through its Memorandum dated May 26, 2025, recommended the cancellation of procurement activities and declaration of failure of bidding for Contract ID No. 25N00011, due to an overlap with a previously implemented project by the Butuan City District Engineering Office, specifically the project titled: "Butuan City - Malaybalay Rd - K1269+000 - K1270+249;

**WHEREAS**, in view of the said recommendation, the BAC convened to deliberate on the matter, and after thorough discussion, unanimously agreed that the overlapping station limits rendered the implementation of the new project technically unfeasible, thereby necessitating a declaration of failure of bidding;

*WHEREAS*, Section 41 Reservation Clause of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A) No. 9184, states that:

The HoPE reserves the right to reject any and all bids, declare a failure of bidding, or not to award the contract in the following situations:

- a) xxx
- b) xxx
- c) For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows:
  - (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE;

**WHEREAS**, taking all the foregoing into consideration, the DPWH Regional Office XIII finds it necessary to declare a failure of bidding for Contract ID No. 25N00011, due to the technical infeasibility brought about by the overlapping project implementation;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved by the Bids and Awards Committee (BAC) of the Department of Public Works and Highways, Regional Office XIII, to:

- 1. Declare a Failure of Bidding for Contract ID No. 25N00011 due to the overlapping with a previously implemented project; and
- 2. Recommend the cancellation of all procurement activities relative to the said project, including the cancellation of its posting in the Civil Works Application (CWA), Philippine Government Electronic Procurement System (PhilGEPS), and the official DPWH websites.
