WHEREAS, March 11, 2025 after opening of bids, the BAC conducted Eligibility Check for the abovementioned contract;

WHEREAS, immediately on the same day, the BAC conducted the preliminary examination of the Technical and Financial Proposals of the bids from the eligible bidders namely, A.J. LAVA Builders Corp. Construction and ORANI Construction & Supply, Inc.;

WHEREAS, the BAC, with the assistance of its Technical Working Group (TWG), conducted the detailed evaluation and post-qualification on November 8, 2023 to November 13, 2023 and, therefore to declared FORTUNE RDC Enterprises as the bidder with the Lowest Calculated Responsive Bid (LCRB) for the abovementioned Contract;

WHEREAS, the Bids and Awards Committee (BAC) of this Office convened on July 08, 2025 relative to **cancel or terminate the conduct of procurement activities** in consistent with the directive set forth in the Republic Act 9184 and its 2016 Revised Implementing Rules and Regulations;

- c) **the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity (PE);**

WHEREAS, due to the above reason, the Bids and Awards Committee (BAC) of this Office deliberated and unanimously agreed to cancel the conduct of procurement activities for Contract ID No. 25CD0174- Construction of Flood Control Structure along Meycauayan River, Sta. 04+575- Sta. 04+675 (Liputan – Nagbalon Section), Meycauayan, Bulacan due to the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity (PE);

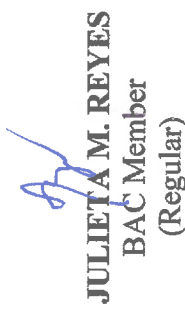

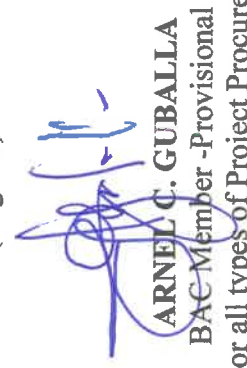
