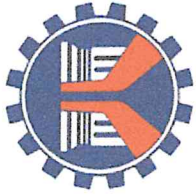
REQUEST FOR EXPRESSIONS OF INTEREST (REOI)

The Department of Public Works and Highways (DPWH), Regional Office V, Old Airport Road, Brgy. 40, Cruzada, Legazpi City through its Special Bids and Awards Committee (BAC), intends to apply the sum indicated below being the Approved Budget for the Contract (ABC) to payment under the contract for the following projects;

The DPWH, Regional Office V now calls for the submission of Applications for Eligibility and Shortlisting documents for:

Project:	24CSF001 Conduct of Geotechnical Investigation for FY 2024 Infrastructure Projects
Location:	Camarines Norte
Objectives:	- o To obtain information relative to the distribution and properties of soils, groundwater and surfaces drainage conditions and other pertinent data necessary for a rational and economic design of any infrastructure project. - o To determine the arrangement of the soil strata or soil profile and engineering properties of the underlying soils, establish its compressibility strength and other characteristics, as well as the soil bearing capacities. - o The results of geotechnical investigations which is among the basic data input/requirements in the detailed engineering design of infrastructure project in order that a safe and economical foundation and slope protection works may be designed.

Interested Consulting Firm must submit their Applications for Eligibility and Shortlisting documents not later than **10:00 A.M. of May 8, 2024** at the BAC Bidding Room, DPWH, Camarines Norte Sub-District Engineering Office, Daet, Camarines Norte by the duly Authorized Representative. The Authorized Representative shall present their Special Power of Attorney or Secretary's Certificate, whichever is applicable, and two (2) valid government issued IDs. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion. The eligibility forms are available at www.dpwh.gov.ph and www.philgeps.gov.ph websites.

In accordance with DPWH D.O. No. 195, series of 1992, pursuant to the provisions of R.A. 544, the procurement and employment of corporations as consultants for the practice of civil engineering under locally-funded projects is not allowed. For Feasibility Studies and Non-Civil Engineering Services involving multi-disciplinary services, corporations, partnerships and sole proprietorship shall be allowed, but licensing requirements on the regulated professions shall be applied.

The BAC shall draw up the short list of consultants from those who have submitted (eligibility documents/Expression of Interest and Application for Eligibility and Shortlisting) and have been determined eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Revised Implementing Rules and Regulations (IRR). The short list shall consist of **five (5)** prospective bidders who will be entitled to submit bids and pay the applicable fee specified above for the bid documents at the **cashier of any DPWH Office**. Should less than five (5) bidders apply for eligibility and shortlisting, pass the eligibility check and/or pass the minimum score of **80 points** required in the shortlisting, the BAC shall consider the same. The criteria and rating system for short listing are:

Experience of Firm	- 60 pts.
Availability of Required Personnel	- 10 pts.
Workload	- 30 pts.
Total	- 100 pts.

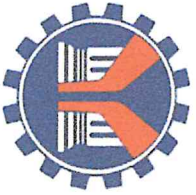
The BAC shall issue Notice of Shortlist/Non-shortlist to participating bidders. Pre-bid conference is scheduled on **May 15, 2024 at 2:00 PM**.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest of outstanding capital stock belonging to citizens of the Philippines.

The Procuring Entity shall evaluate bids using Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The technical and financial proposal shall have a weight of sixty-five (65) and thirty-five (35) percent, respectively. Only bids with the technical proposals passing the **eighty percent (80%)** minimum rating points shall have their financial proposals opened and evaluated.

Shortlisted bidders shall present their **ORIGINAL OFFICIAL RECEIPT OF PAYMENT** for Bid Documents (project specific) to the BAC Bidding Room, DPWH, Camarines Norte Sub-District Engineering Office, Daet, Camarines Norte before the deadline, which is the date of bidding. The Owner or Authorized Representatives will be allowed to transact business relative to bidding matters. Representatives are required to submit Special Power of Attorney or Secretary's Certificate, whichever is applicable, and two (2) valid government issued IDs to be allowed to transact business. Shortlisted bidders must be in the Document Request List (DRL) of the PhilGEPS website and secure a print-out copy showing that they are included in the list.
