2. Bids received in excess of ABC shall be automatically rejected at the bid opening.
3. Interested consultant must submit their eligibility documents on or before **March 6, 2025** at the Procurement Office, Department of Public Works and Highways-Nueva Vizcaya 1<sup>st</sup>. District Engineering Office. Application for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
4. The BAC shall draw up the short list of consultant from those who have submitted eligibility documents/Expression of Interest and have been determined as eligible in accordance with the provision of Republic Act 9184 (RA9184), otherwise known as the Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of Three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short list are based on the experience of the consultant, qualification of personnel and job capacity pursuant to Department Order No. 143, series of 2022.
5. Pre-Bid Conference shall be held on **March 13, 2025 at 9:00 A.M. at the Bidding Room**
6. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the IRR of RA 9184. Bidding is restricted to Filipino Citizens sole proprietorship, partnership, or organizations with at least 60% interest or outstanding capital stock belonging to citizens of the Philippines.
7. The Department of Public Works and Highways-Nueva Vizcaya 1<sup>st</sup> District Engineering Office, Bayombong, Nueva Vizcaya shall evaluate bids using the Quality Cost Base Evaluation (QCBE) procedure. The Department of Public Works and Highways-Nueva Vizcaya 1<sup>st</sup> District Engineering Office shall indicate the weights to be allocated for the Technical and Financial Proposal. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to Bidders.
8. The Eligibility Screening Forms will be available at the Procurement Office, Department of Public Works and Highways-Nueva Vizcaya 1<sup>st</sup> District Engineering Office, Bayombong, Nueva Vizcaya, upon payment of a refundable cost for the bidding documents to the DPWH-NV 1<sup>st</sup> DEO, Bayombong, Nueva Vizcaya.
9. Bids must be delivered on or before **March 25, 2025, 9:00AM.** at the Bids and Awards Committee Office, Department of Public Works and Highways-Nueva Vizcaya 1<sup>st</sup> District Engineering Office, Bayombong, Nueva Vizcaya. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause18.1.
- 10 Bids will be opened in the presence of the owner or bidder's authorized representative who choose to attend at the above. Late bids shall not be accepted.
- 11 The DPWH Nueva Vizcaya District Engineering Office reserves the right to accept or reject any bid to annul the bidding process, and to reject all bids at any time prior to contract award, without Incurring any liability to the affected bidder or bidders
