2. Construction of Multi-Purpose Building, Barangay Casiawan, Cabucgayan, Biliran

Scope of Work : Conduct drilling of 6 bore holes at 10 meters for soft soil and 5 meters into

hard strata (N-Value>30) for all items.

- 1. The DPWH–Biliran District Engineering Office, Naval, Biliran, through the **(CY 2023 GAA Regular Infra Fund)** intends to apply the sum above stated being the Approved Budget for the Contract (ABC) to payments under the contract for the abovementioned contracts. Bids received in excess of the ABC shall be automatically rejected /declared non-complying at the opening of the financial proposal.
- 2. The DPWH Biliran District Engineering Office, Naval, Biliran now calls for the submission of Eligibility Documents for the preparation of Subsurface Exploration/Geotechnical Investigation for the Proposed Construction of Flood Control Projects and the subject of the Terms and Reference (TOR). Interested Consultants must submit their eligibility documents on or before January 23, 2024 until 2:00 P.M. (Submission/Opening of Eligibility Documents) at the BAC Office with address given below. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 3. The BAC shall draw up the short list of consultants from those who have submitted Eligibility Documents and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise as the Government Procurement Reform Act" and its Implementing Rule and Regulations (IRR). The short list shall consist of three (3) prospective bidders/consultants who will be entitled to attend Pre-Bid Conference and submit bids/proposals. The criteria and rating system for short listing are:
 - 1. Experience of the Firm (35 points)
 - 2. Qualifications of Key Personnel of the Firm (40 Points)
 - 3. Job Capacity (25 points). For a total of 100 points.
- 4. Bidding will be conducted through open competitive bidding procedures for the procurement of Consulting Services using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, organizations or joint venture with at least seventy five percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 5. The Procuring Entity shall evaluate bids using the Quality-Cost Based Evaluation (QCBE): **Passing Technical Scores and Quality-Cost Weights** procedure. Only bids whose technical proposals pass the minimum technical evaluation score of seventy five percent (75%) shall have their financial proposals opened and evaluated. The technical proposal shall carry eighty percent (80%) weight in the evaluation. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to bidders.
- 6. The contract shall be completed within **60 Calendar Days**.

7. The DPWH-Biliran District Engineering Office, Naval, Biliran reserves the right to accept or reject any and all bids, to annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability or obligation to the affected bidder or bidders.
