





The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the Department of Public Works and Highways (DPWH), Regional Office XI, represented herein by **EDITHA G. MONTILDE**, District Engineer, duly authorized for this purpose, with main office address at R. Magsaysay Avenue, Davao City, hereinafter referred to as the "**PROCURING ENTITY**";

-and-

CH BEATISULA ENGINEERING CONSULTANCY, a single proprietorship organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at Thames St. Riverview Village, Bacaca, Davao City, Davao del Sur represented herein by **SARAH JOY H. BEATISULA**, OIC-Authorized Managing Officer, duly authorized for this purpose, hereinafter referred to as the "**CONSULTANT**";

WHEREAS, the PROCURING ENTITY is desirous, that the Consultant execute **Contract ID No. 25CSLC03 - CONSULTANCY SERVICES FOR GEOTECHNICAL AND GEOLOGICAL SURVEYS/ INVESTIGATIONS FOR THE PROPOSED CONSTRUCTION OF MUNICIPAL GYM, KAPALONG, DAVAO DEL NORTE**

(Hereinafter called "the Works"), and the Entity has accepted the bid **Three Hundred Eighty-Five Thousand One Hundred Thirteen Pesos (P 385,113.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THEREFORE, for and consideration of the foregoing premises, the parties hereto agree as follows:

 - (10) Eligibility Requirements, Documents and/or Statements;
 - (11) Performance Security
 - (12) Other contract documents that may be required by existing laws and/or the Entity
