


TANGGOL, Regional Director, duly authorized for this purpose, with office address at Engineer's Hill, Baguio City, hereinafter called the "PROCURING ENTITY,"

and

DBADSUARA ENGINEERING CONSULTANCY, a company existing under and by virtue of the laws of the Republic of the Philippines, with office address at Rm 209 2/F Saunterfield Bldg., Ortigas Ave. Ext., Barangay Sto. Niño, Cainta, Rizal, represented herein by DON B. ADSUARA, duly authorized for this purpose, hereinafter called the "SERVICE PROVIDER."

WHEREAS, the PROCURING ENTITY is desirous that the SERVICE PROVIDER executes 25CSP001: Consultancy Service for the Conduct of Geotechnical Investigation for FY 2025 Projects, (hereinafter called "the WORKS"), and the PROCURING ENTITY has accepted the bid of Six Million Four Hundred Ninety-Eight Thousand Eight Hundred Eighty-Eight Pesos and Fifty Centavos (Php 6,498,888.50) by the SERVICE PROVIDER for the execution and completion of such Consulting Services and the remedying of any defects therein.

The PROCURING ENTITY hereby covenants to pay the SERVICE PROVIDER in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
