



CONTRACT AGREEMENT

THIS AGREEMENT, made this 13 0 MAY 2025 by and between:

The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the **DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-CORDILLERA ADMINISTRATIVE REGION (DPWH-CAR)**, represented by **KHADAFFY D. and


