**WHEREAS**, the Department of Public Works and Highways – Iligan City District Engineering Office thru its Bids and Awards Committee posted the Invitation to Bid for the Contract ID No. **24CKM0001 –Real Property Appraisal Services for Properties Affected by the Project “Paving of Unpaved Roads along Lanao Del Norte Interior Circum. Rd K1533+398 – K1533+443**, and posted the same in the DPWH website, PhilGEPS website, and in the conspicuous place in the premises of the procuring entity continuously for 7 days;
