The bidding documents can be obtained from the RDC Secretariat after payment of non-refundable amount of **Five Hundred Pesos (P 500.00)** at the DPWH Cash Section. Interested bidders may get the auction documents from RDC Secretariat, from **February 21- 27, 2025, 8:00 A.M. to 5:00 P.M. Wednesday to Friday**. Viewing an inspection of the said properties is scheduled on **February 21, and 25-27, 2025**. The DPWH will hold a Pre-Auction Conference on **February 25, 2025, 10:00 AM at DPWH Equipment Management Division**, which shall be open to all interested bidders who have purchased the auction documents.

The Public Auction is open to all prospective bidders who shall comply with the following eligibility requirements:

Certified True Copy of Documentary Requirements
1. Latest Mayor's / Business Permit
2. Latest Tax Clearance Certificate
3. Security and Exchange Commission (SEC) or Department of Trade and Industry (DTI) Certificate

Auction offer together with the Certified True Copy of documentary requirements and **Auction bond equivalent to 10 percent (10%) of Minimum Government Selling Price (GMSP)** in the form of cash or manager's check shall be submitted in a sealed envelope. The RDC-Secretariat shall receive the sealed envelope **on or before February 28, 2025 at 10:00 AM**. All auction offer shall be addressed to:

Auction offer shall be submitted personally by the company owner, in lieu to his/her absence, a notarized Special Power of Attorney (SPA) is hereby required for the duly representative. Otherwise, said offer will be disregarded.

Bidder with the highest offer, with an offer not lower than the Government Minimum Selling Price (GMSP) shall be considered the winning bidder. Upon declaration of the winning bidder, the auction bond will be returned to the non-winning bidder(s). The auction bond of the winning bidder shall be considered as partial payment and the remaining amount from the offer shall be paid within **five (5) working days from the date of the receipt of Notice of Award** in the form of cash or manager's check. The ten (10%) auction bond shall be **forfeited in case of failure to settle the remaining balance of the offer.**

The Department of Public Works and Highways reserves any right to reject any bid, or annul the bidding process, without incurring any liability to any bidders should it be found that, the bidding is disadvantageous to the government or violate any existing law.
