 - a. Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for cooperatives;
 - b. Filipino citizen or 60% Filipino-owned partnership/corporation;
 - c. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2 of the IRR;
 - d. Completion of similar contract costing at least 50% of ABC;
 - e. Net Financial Contracting Capacity (NFCC) at least equal to the ABC.
- 4. Prospective bidders may obtain further information from **DPWH-Isabela Third District Engineering Office** and inspect the Bidding Documents at the **BAC Secretariat**, **Procurement Unit Office**, **DPWH-Isabela Third District Engineering Office**, **Tagaran**, **Cauayan City**, **Isabela** during weekdays from **8:00 A.M. to 5:00 P.M**.
