INVITATION TO BID

For

24GFO0020 - Purchase of Tires and Batteries for Use in Motor Vehicles and Equipments Assigned at DPWH Albay 3rd District Engineering Office

The ***Department of Public Works and Highways (DPWH) - Albay 3rd District Engineering Office (DEO)***, through ***Republic Act (RA) 11975 - General Appropriations Act (GAA) 2024 - SR2024-05-016663 (Routine Maintenance of National Roads)*** intends to apply the sum of ***One Million Eight Hundred Ninety Five Thousand Nine Hundred Thirty Seven Pesos and Seventy Five Centavos (P 1,895,937.75)*** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***above-stated contract***. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

The ***DPWH - Albay 3rd DEO***, through its Bids and Awards Committee (BAC), now invites bids for the above procurement project. Delivery of goods is required within a thirty (30) calendar days (CD) contract duration. Bidders should have completed, within ***five (5) years*** from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary ***"pass/fail"*** criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Prospective bidders may obtain further information from ***DPWH - Albay 3rd DEO***, and inspect the Bidding Documents at the address given below during ***Monday-Friday (8:00AM-12:00PM, and 1:00PM-5:00PM)***.

A complete set of Bidding Documents may be acquired by interested Bidders on ***June 9, 2024 until the submission of bid***, from the given address and website below, and upon payment of an applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Five Thousand Pesos (P 5,000.00)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

Bidders can make payment for the purchase of Bid Documents at any DPWH Field office. Should they opt to make such payment in our office, they are advised that the **cut-off time** for securing the memo for order of payment is at **9:30 AM**, and the order of payment itself from the accounting section for such fee is at **9:45 AM**, respectively, on the deadline date for the receipt by the BAC of bids.

The *DPWH - Albay 3rd District Engineering Office* will hold Pre-Bid Conference on **June 18, 2024, 9:00 AM**, at the **Procurement Unit Office, Paulog, Ligao City**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through *manual submission* at the *Procurement Unit Office, Paulog, Ligao City*, on or before **July 1, 2024** at **10:00 AM**. Late bids shall not be accepted.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

Bid Opening shall be on **July 1, 2024, right after the deadline for the submission and dropping of bids**, at the **Procurement Unit Office, Paulog, Ligao City**. Bids will be opened in the presence of the bidders' representative/s who
