 - a. Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for Cooperatives;
 - b. Mayor's/Business permit issued by the City of Municipality where the principal place of business of the prospective bidder is located or the equivalent document for exclusive economic zones or areas;
 - c. Tax Clearance per Executive Order 398, Series of 2005, as finally reviewed and approved by the BIR;
 - d. Filipino Citizen or 60% Filipino-Owned partnership/corporation;
 - e. Completion of similar contract costing at least 25% of the ABC within 2 years; and
 - f. Net Financial Contracting Capacity (NFCC) at least equal to the ABC or in lieu of the NFCC computation, a committed line of credit (CLC) specific to the contract to be bid from universal or commercial bank.
 - g. PhilGEPS
5. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
