The **DPWH-Isabela 3rd District Engineering Office**, through **Engineering & Administrative Overhead CY 2025 - FY 2025 RA 12116 REGULAR 2025 CURRENT** intends to apply the sum of **₱ 6,894,000.00** being the Approved Budget for the Contract (ABC) to payments under the **Contract ID 25GBG03 Lot 2: Furnishing and Delivery of Three (3) Units Plug-in Hybrid Electric Vehicles Pick-up Truck 4x4 for the use of DPWH Isabela Third District Engineering Office, Brgy. Tagaran, Cauayan City, Isabela**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

To be eligible to bid for this contract, a contractor must meet the following major requirements:

- a. Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for cooperatives;
 - b. Filipino citizen or 60% Filipino-owned partnership/corporation;
 - c. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2 of the IRR;
 - d. Completion of similar contract costing at least 50% of ABC;
 - e. Net Financial Contracting Capacity (NFCC) at least equal to the ABC.
4. Prospective bidders may obtain further information from **DPWH-Isabela Third District Engineering Office** and inspect the Bidding Documents at the **BAC Secretariat, Procurement Unit Office, DPWH-Isabela Third District Engineering Office, Tagaran, Cauayan City, Isabela** during weekdays from **8:00 A.M. to 5:00 P.M.**

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **Instruction To Bidders (ITB) Clause 14**.

Bid opening shall be on **June 18, 2025 at 9:00 A.M.**, at **New Conference Room, DPWH-Isabela Third District Engineering Office, Tagaran, Cauayan City, and Isabela** and/or through live streaming on Youtube: <https://www.youtube.com/@DPWHIsabela3rdDEO> which shall be open to prospective bidders or bidder's representatives who chose to attend the activity, subject to existing health protocol.
