



**INVITATION TO BID FOR INSTALLATION/APPLICATION OF ROAD SAFETY
FACILITIES (ROADWAY LIGHTING) ALONG PAGADIAN CITY -
ZAMBOANGA CITY ROAD, STA. (K1673+430 – K1674+307) 1ST DEO
ZAMBOANGA DEL SUR**

1. The Department of Public Works and Highways 1st DEO, Pagadian City, through the **11101101 – Regular Agency Fund – General Fund – New General Appropriations – Specific Budgets of National Government Agencies/SR2025-02-006332** intends to apply the sum of **Php 2,450,980.39** being the ABC to payments under the contract for **25GJE0001 – INSTALLATION/APPLICATION OF ROAD SAFETY FACILITIES (ROADWAY LIGHTING) ALONG PAGADIAN CITY - ZAMBOANGA CITY ROAD, STA. (K1673+430 – K1674+307) 1ST DEO ZAMBOANGA DEL SUR**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Public Works and Highways 1st DEO, Pagadian City now invites bids for the above Procurement Project. Delivery of the Goods is required by 75 Calendar Days. Bidders should have completed, within **3 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from Department of Public Works and Highways 1st DEO, Pagadian City and inspect the Bidding Documents at the address given below during Monday to Friday (8:00AM to 5:00PM).
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 01, 2025** from the given address and website(s) below www.dpwh.gov.ph and www.philgeps.gov.ph: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.

6. The Department of Public Works and Highways 1st DEO, Pagadian City, will hold a Pre-Bid Conference on **March 10, 2025 (10:00AM)** at DPWH 1st DEO, Procurement Unit, Pagadian City, and/or through video conferencing or webcasting via FB LIVE, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, on or before **March 24, 2025 (10:00AM)**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **March 24, 2025 (10:00AM)** at the given address below and/or via FB Live. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Department of Public Works and Highways 1st DEO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
