INVITATION TO BID FOR CONTRACT ID NO. 25GKN0002 - Supply and Delivery of Laboratory Equipment for use in the operation of DPWH **Bukidnon 4th District Engineering Office Quality Assurance Section**

- 1. The Department of Public Works and Highways - Bukidnon 4th District Engineering Office through RA 11975 Extended Regular 2024 Continuing EAO (SR2025-02-005269) intends to apply the sum of Two Million Two Hundred Twenty Thousand Pesos (P 4,994,050.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Purchase Request No. dated. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Department of Public Works and Highways Bukidnon 4th District Engineering Office 2. now invites bids for 25GKN0002 - Supply and Delivery of Laboratory Equipment for use in the operation of DPWH Bukidnon 4th District Engineering Office Quality Assurance Section. Delivery of the Goods is required as specified in the Schedule of Requirement. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from Department of Public Works and 4. Highways - Bukidnon 4th District Engineering Office and inspect the Bidding Documents at the address given below during weekdays from 8:00 am - 5:00 pm.
- A complete set of Bidding Documents may be acquired by interested Bidders on 5. April 17, 2025 until 10:00 am of May 06, 2025 from the given address and website(s) below and upon payment for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00).
 - [NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]
- The Department of Public Works and Highways Bukidnon 4th District Engineering Office 6. will hold a Pre-Bid Conference on April 24, 2025 10:00 am at BAC - Bidding Rm. DPWH Bukidnon 4th District Engineering Office, Valencia City Gymnasium and Cultural Center, Valencia City, Bukidnon, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *May 06, 2025, 10:00 am.* Late bids shall not be accepted.

Bidding Documents may be purchased and Bid Proposals may be submitted through an authorized representative together with the original copy of Special Power of Attorney (SPA) for Sole Proprietorship; or Board/Partnership/Joint Venture Resolution with Secretary's Certificate for Corporation/Partnership/Joint Venture/Cooperative) which is Contract Specific and presentation of Company ID or any government issued ID.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *May 06, 2025, 10:00 am* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Department of Public Works and Highways Bukidnon 4th District Engineering Office reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
