WHEREAS, on the same date upon the bid evaluation from the technical working group for Long Island Builders & Const. and RL Enterprises it was found out that it was above ABC, in accordance to the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 Section 33 that stated "In case any of the requirements in the second envelope of a particular bid is missing, incomplete or patently insufficient, and/or if the submitted total bid price exceeds the ABC, the BAC shall rate the bid concerned as "failed";
