

WHEREAS, upon evaluation the Bids and Awards Committee (BAC) found out that Champion Commercial has an "Expted Tax Clearance" and Thian Te Auto Supply has "No Applicable Business Papers Submitted" which is a requirement in participating in procurement of goods. Therefore, Champion Commercial and Thian Te Auto Supply is disqualified.




