**INVITATION TO BID FOR CONTRACT ID NO. 24GND0010 - SUPPLY AND DELIVERY OF DIESEL FUEL AND EXTRA GASOLINE FOR USE IN SERVICE VEHICLES, HEAVY EQUIPMENT AND GRASSCUTTERS OF THE LOWER AGUSAN DEVELOPMENT PROJECT (LADP).**

The **DPWH Butuan City District Engineering Office**, through the **FY 2024 General Appropriations Act (GAA)** intends to apply the sum of **P 1,956,926.40** being the ABC to payments under the contract for **Contract ID No. 24GND0010 – Supply and Delivery of Diesel Fuel and Extra Gasoline for use in Service Vehicles, Heavy Equipment and Grass Cutters of the Lower Agusan Development Project (LADP)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **DPWH Butuan City District Engineering Office** now invites bids for the above Procurement Project, as follows:

Delivery of the Goods is required within **30 calendar days** upon receipt of the Notice to Proceed (NTP). Bidders should have completed, within **10 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino Citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183. Prospective Bidders may obtain further information from **DPWH Butuan City District Engineering Office** and inspect the Bidding Documents at the address given below during **office hours from 8:00 AM to 5:00 PM**.

A complete set of Bidding Documents may be acquired by interested Bidders on **July 11, 2024-July 30, 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the

GPPB, in the amount of **P 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

The **DPWH Butuan City District Engineering Office** will hold a **Pre-Bid Conference** on **July 18, 2024 at 2:30 PM at DPWH - Butuan City District Engineering Office NOA Hall**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. Late bids shall not be accepted.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

Bid opening shall be on **July 30, 2024 at DPWH - Butuan City District Engineering Office NOA Hall at 2:30 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
