INVITATION TO BID FOR

PROCUREMENT OF DPWH SECURITY SERVICES FOR 3 SECURITY GUARDS FOR DEPLOYMENT AT DPWH-IFDEO COMPOUND, CITY OF ILAGAN, ISABELA

The Department of Public Works & Highways (DPWH) thru its Bids and Awards Committee for Goods (BAC), through **Engineering & Administrative Overhead**, intends to apply the sum of **EIGHT HUNDRED SEVENTY SIX THOUSAND SIX HUNDRED PESOS (P876,600.00)** being the Approved Budget for the Contract (ABC) to payments under **Contract ID 25GBE01**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Contract Duration is **One (1) year**.

The **DPWH-Isabela 1st District Engineering Office** through its Bids and Awards Committee now invites for the Procurement of **DPWH Security Services for 3 Security Guards for Deployment at DPWH-IFDEO Compound, Osmeña, City of Ilagan, Isabela**. Delivery of the goods is required as specified in the Schedule of Requirement. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project whose value must be at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (R-IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnership, or organizations with one hundred percent (100%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain information from the BAC for Goods Secretariat and inspect the Bidding Documents at the address given below during Monday to Friday at 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be purchased by Interested Bidders on **January 8, 2025 to January 21, 2025** from the Secretariat, BAC for Goods, Procurement Unit, DPWH-Isabela First District Engineering Office, City of Ilagan, Isabela upon payment of an appropriate fee for the Bidding Documents in the amount of **One Thousand Pesos (Php1,000.00)**.

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the DPWH. However, the Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of Bids.
