INVITATION TO BID FOR 25GDJ03 - Repair and Maintenance of National Roads within Quezon 2nd District (Hot Mix)

1. The Department of Public Works and Highways Quezon 2nd District Engineering Office, Dalahican Road, Lucena City, through the **01105565-Regular Agency Fund-General Fund** intends to apply the sum of **P 2,978,220.00** being the ABC to payments under the contract for **25GDJ03 - Repair and Maintenance of National Roads within Quezon 2nd District (Hot Mix)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Public Works and Highways Quezon 2nd District Engineering Office, Dalahican Road, Lucena City now invites bids for the above Procurement Project. Delivery of the Goods is required by 30 Calendar Days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from Department of Public Works and Highways Quezon 2nd District Engineering Office, Dalahican Road, Lucena City and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 28, 2025** until before **9:00 A.M of June 17, 2025** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The Department of Public Works and Highways Quezon 2nd District Engineering Office, Dalahican Road, Lucena City will hold a Pre-Bid Conference¹ on **June 4, 2025 @ 9:00 A.M** at DPWH Quezon 2nd District Engineering Office (BAC Office) or through video conferencing or webcasting *via* ZOOM with ID: 5164739727 password: Q2bacBid and **YOUTUBE** **CHANNEL:** <https://www.youtube.com/channel/UCW8OddCVSjShbqER5gzy9PQ> or Face to Face at the DPWH Quezon 2nd District Engineering Office which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on before **June 17, 2025 @ 9:00 A.M**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 17, 2025 @ 9:00 A.M** at DPWH Quezon 2nd District Engineering Office, Dalahican Road, Lucena City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. As per GPPB Resolution No. 15-2021, dated 14 October 2021 Failure by the prospective bidder to update its Philgeps Certificate of Platinum Registration and Membership with the current and updated Class "A" Eligibility Documents covered by Section 8.5.2 of the 2016 revised IRR of RA 9184 shall result in the automatic suspension of the validity of its Certificate of Platinum Registration and Membership until such time that all of the expired class "A" Eligibility Documents has been updated.
11. The Department of Public Works and Highways Quezon 2nd District Engineering Office, Dalahican Road, Lucena City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


