The DPWH Regional Office XII will hold a Pre-Bid Conference on July 30, 2024 at 1:00PM at the Office of the Chairman, DPWH RDC, 2nd Floor, Administrative Building, DPWH Regional Office XII, Mabini St. Corner Alunan Avenue, Koronadal City, South Cotabato, which shall be open to prospective bidders.

Interested bidders are required to submit their bid proposal and bond in the amount not less than the Government Minimum Selling Price of the lot to be bid out in the form of Cash, Cashier's or Manager's Check, Attention: Chairman, Regional Disposal Committee, 2nd Floor, Administrative Building, DPWH Regional Office XII, Mabini St. Corner Alunan Avenue, Koronadal City, South Cotabato, not later than 12:00NN on August 6, 2024.

Prospective bidders shall submit their bids in two (2) separate bid envelopes to the RDC Chairman. The first envelope shall contain the bid bond and the second envelope shall contain the bid form/bid offer. The requirements and documents to be submitted are:

- The description of the items/lots with corresponding bid offer clearly indicated in figures and in words;
- The name and signature if the bidder;
- The business or residence number and address of the bidder;
- The Business License Number or Residence Certificate number of the bidder;
- Revised General Terms and Conditions offered regarding bidder's bond, payment, default, and delivery; and

- f) Special Power of Attorney (SPA) duly notarized if representatives and not the Business Owner as appearing in the business permit.

All bids will be opened at 1:00 PM on August 6, 2024 at the above-mentioned address.

The Department of Public Works and Highways reserves the right to reject any or all bids, waive any defect contained therein and accept the offer most advantageous to the government.
