- 3. Warranty shall be for a mininum of one (1) year for equipment from date of acceptance by the end-user.

- 5. PhilGEPS Registration Number and Mayor's Permit shall be attached upon submission of the quotation. DTI /SEC and Latest Tax Clearance shall be submitted before the award of Purchase Order (P.O.).
- 6. To establish financial capability, bidders may attach/includenin its quotation a Committed Line of Credit (CLC) equivalent to 10% of the ABC, from a commercial or Universal Bank.
- 7. Bidders must quute for all of the items and shall submit a proposal on each item and evaluation and award of contract will be undertaken on a lump sum basis.
