**WHEREAS**, Department of Public Works and Highways Davao de Oro 1st District Engineering Office advertised and Posted the Notice of Alternative Methods of Procurement No. 2025-010 at the PHILGEPS AND DPWH websites and at conspicuous places of this Office for seven (7) calendar days, inviting bidders to apply for eligibility and submit bid proposals for the above-named Purchase Request No.;

**WHEREAS**, the Approved Budget for the Contract (ABC) for Purchase Request (PR) No. 2025-05-032, Supply and Delivery of Consolidated inventory/common office supplies for use in the DPWH Davao de Oro 1<sup>st</sup> District Engineering Office, Nabunturan, Davao de Oro, is Php999,637.50;

**WHEREAS**, the schedule for Dropping and Opening of Bids was set on June 24, 2025, as posted on PhilGEPS and DPWH websites;

**WHEREAS**, on June 24, 2025, only one (1) bidder namely **MULTI DRAW CONSUMER GOODS TRADING** submitted a bid and was rated "passed" during eligibility check and was then rated "eligible" therefore declaring the **MULTI DRAW CONSUMER GOODS TRADING** as "complying";

**WHEREAS**, upon further evaluation it was found that the attached Certificate of PhilGEPS Registration of **MULTI DRAW CONSUMER GOODS TRADING** was a Red Certificate in contrast to the required Platinum Certificate of Membership in the Request for Quotation (RFQ);

**WHEREAS**, on June 30, 2025, Bids and Awards Committee (BAC) issued a cancellation for PR No. 2025-05-032, Supply and Delivery of Consolidated Inventory/Common Office Supplies for Use in the DPWH Davao de Oro 1st District Engineering Office, Nabunturan, Davao de Oro.;

**WHEREAS**, pursuant to Section 23.6 of the Implementing Rules and Regulations of Republic Act 9184 (otherwise known as "the law"), *"the Procuring Entity concerned reserves the right to review the qualifications of the bidder at any stage of the procurement process if the Procuring Entity has reasonable grounds to believe that a misrepresentation has been made by the said bidder, or that there has been a change in the bidder's capability to undertake the project from the time it submitted its eligibility requirements. Should such review uncover any misrepresentation made in the eligibility requirements, statements or documents, or any changes in the situation of the bidder which will affect the capability of the bidder to undertake the project so that it fails the eligibility criteria, the Procuring Entity shall consider the said bidder as ineligible and shall disqualify it from obtaining an award or contract, in accordance with Rules XXI, XXII, and XXIII of this IRR."*;


