BAC RESOLUTION FOR GOODS (A) RECOMMENDING "FAILURE OF BIDDING" (1ST FAILURE) FOR THE ABOVE-NAMED CONTRACT; AND (B) TO CANCEL THE SCHEDULED PROCUREMENT ACTIVITIES

BAC RESOLUTION NO. 2025-FB-005

WHEREAS, on July 4, 2025, the Bids and Awards Committee (BAC) passed BAC Resolution No. 2025-PDQ-002 declaring MJAS ZENITH TRADING as the non-responsive and post-disqualified bidder for the above-stated contract;

WHEREAS, Ms. Didi Superales, Authorized Representative of MJAS ZENITH TRADING, received a notice of disqualification on July 8, 2025, which was dated July 4, 2025, and detailing the reasons for the company's disqualification;

WHEREAS, on July 11, 2025, the BAC received a Motion for Reconsideration, dated July 10, 2025, from Mr. Samson A. Lato of MJAS Zenith Trading, requesting for reconsideration;

WHEREAS, upon careful evaluation and a thorough deliberation of the grounds raised by the said supplier, the Bids and Awards Committee resolve the following ground;

1. Failed to meet the required minimum technical specification (flight speed, range, operating temperature, field of view)

WHEREAS, a letter dated July 16, 2025, notifying the unanimous decision of the BAC that their Motion for Reconsideration was hereby DENIED, was sent to MJAS ZENITH TRADING and received by Ms. Superales on July 24, 2025, with an statement: *"We will not file Protest"*;

WHEREAS, MJAS ZENITH TRADING is the only bidder dropped/submitted bids for PR No. 24GI0150 and since it has no intention to file protest, Pursuant to Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides: "The BAC shall declare the bidding a failure when:

- c. All bids fail to comply with all the bid requirements or fail post-qualification"

NOW THEREFORE, the herein Bids and Awards Committee for Goods resolves as it is hereby resolved:

- A. To declare a failure of bidding (1st Failure) due to the single participating supplier/bidder was declared post-disqualified; and
- B. To cancel all scheduled procurement activities for the above-stated contract and recommend a rebidding;
