Justification:

- Modification in station limits for the 1st section due to the following:
 - Widening for 2nd section is prioritized (to tap with FY 2017 road widening project);
 - Change in end limit from K1490+190 to K1490+155 since said deleted section will be covered by the adjacent project widening of Sto. Niño Bridge I and approaches.
 - Change in start limit for section 1 from K1488+382 K1489+039.15 since allocation is already
 insufficient to cover the remaining original limits.
- Additional project component construction of drainage structures along road to address runoff since the project is located in a flood prone and commercial area in Talaingod.
- Decrease in physical target for road widening from 4.520 Lane Km to 3.136 Lane Km due to the following:
- Inclusion of additional project component including provision of sidewalk, curb and gutter.
- Scope of work also includes widening of 17 flaring sections.
- · Cost per component was based on previously published MYPS.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
