Justification:

Increase in physical target from 9.60 lane km to 10.51846 lane km due to:

- The road runs on a combination of rolling to mountainous terrain (mostly rolling terrain) as per actual site condition instead of the anticipated mountainous terrain for the entire stretch; and
- The road design based on the actual terrain requires earthworks with a maximum average of 10 m for excavation and maximum average of 7 meters for fill section instead of the anticipated excavation height of at least 15 m and fill height of 10 m, hence, lower unit cost.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
