Increase in physical target from 5.43 lane km to 5.578 lane km and with modification in project limits were due to the following:

 Change/adjustment in station limits to prioritize damaged paved sections (based on actual site condition) which are deemed necessary for reconstruction in order to prevent traffic accidents. Attached is the Visual Road Assessment Form for these sections; and

Increase in physical target since as per design based on the actual site condition, it requires lesser surplus
common excavation (only 2,242 cu.m.) than anticipated, hence, project limits were extended to cover priority
adjacent sections which need reconstruction.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
