Decrease in physical target from 1.960 Lane Km to 1.860 Lane Km with change in station limits due the inclusion

- Necessary miscellaneous structures such as center island and street lights complete with warning, information and regulatory signs, in order to make the road safe for motorists and pedestrians (24.38% of the total cost); and
- <u>Drainage</u> and slope protection structures such as RCPC (610mm, 1520mm, and 1830mm dia), manholes (1520mm and 1830mm dia), etc. to prevent occurrence of flooding and accommodate the volume of water inasmuch as said project is in a flood-prone area.

Based on our evaluation, the submitted request for modification of the said project is in order hence, it is respectfully recommended to the Secretary for his consideration and approval.
