Decrease in physical target from 2.320 lane km to 1.880 lane km due to the following:

The road runs on a combination of flat to rolling terrain instead of the anticipated flat terrain only. Hence, the
road design requires side cuts of up to 6.00 m which entails higher volume of excavation materials and
downgrading to conform to the DPWH Design Guidelines and Standards (Horizontal and Vertical Alignment and
Road Width), resulting to the increase in unit cost.

 Project also includes construction of double barrel box culvert, minor drainage structures, installation of metal beam guardrails, provision of detour and application of reflectorized thermoplastic pavement markings.

Based on our evaluation, the submitted request for modification of the said project is in order, hence, approval hereof is recommended.
