Justification:

Decrease in physical target from 1.520 lane km to 1.180 lane km due to the following:

- The road runs on a combination of flat to rolling terrain instead of the anticipated flat terrain for the entire section. Hence, the road design requires side cuts up to 9m which entails higher volume of excavation materials and downgrading to conform to the DPWH Design Guidelines and Standards (Horizontal and Vertical Alignment and Road Width) resulting to increase in unit cost.
- Project also includes application of reflectorized thermoplastic pavement markings.

Based on our evaluation, the submitted request for modification of the said project is in order, hence, approval hereof is recommended.
