Justification

Increase in physical target for widening of road from 2.452 lane km to 3.630 lane km with modification in project limits due to the following:

- The road runs on a very flat terrain instead of the anticipated combination of flat to rolling terrain, hence, only requires very minimal earthworks. As such, limits was extended to cover the adjacent section which also needs widening; and
- The design of the road is only on-grade with very minimal correction on the vertical and horizontal alignments.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
