## Justification:

Deletion of one station limit and revision of end limit resulting from the decrease in the physical target of 234 Lineal Meters (from 3,148 Lineal Meters to 2,914 Lineal Meters) due to:

- K1474+091-K1474+109 was deleted because it has already an existing 60"ø RCPC. K1474+300-K1475+846 is reduced due to inclusion of necessary miscellaneous structures such as trees furnishing and transplanting, thus end limit revised.
- Massive embankment borrow of 10,198 cu.m. which constitutes 3.34% of the total project cost
