## Justification:

Modification in project limits due to the following:

- To be contiguous with the adjacent P 150 M project (Project #3) under 2018 with the same scope of work and along the same road network which ends at K1735+950. The 1<sup>st</sup> three FY 2018 GAA adjacent widening projects have modification in project limits (decrease for the 1<sup>st</sup> two projects and increase for the 3<sup>rd</sup> project), hence, the start limits of this 4<sup>th</sup> widening project (Project #4) along the same road network shall be modified correspondingly;
- End limits of the 1<sup>st</sup> section modified to tap/connect with approaches (A) of the bridge widening project under FY 2018 GAA (DEO project) which starts at K1737 + 040 instead of K1737 + 033;
- Limits of section 2 was modified to prioritize/cover the adjacent gap section (K1737 + 600 K1741 + 987) that also needs widening in order to avoid any bottlenecks along the section especially that it is along a primary road. K1737 + 600 is the end limits of Approach (B) of a bridge widening project under FY 2018 GAA (DEO project) while K1741+987 is the start of an existing concrete pavement (under FY 2017 GAA project); and

 In addition, widening of these gap sections needs to be prioritized since these are mostly located on curve sections and approaching bridges that are also scheduled to be widened this year. Increase in physical target from 9.492 lane km to 10.93884 lane km due to the following:

- The road section mostly runs on a flat terrain with portion of rolling terrain. Said flat terrain only requires minimal earthworks, hence, lower unit cost; and
- The excavation works of the project particularly side cuts have average height ranging from 3-5 meters only while embankment height is up to 5 m only instead of the anticipated excavation and embankment heights of at least 5 meters and 3 meters, respectively.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
